**GENERAL ORDINANCE 34\_20**

AN ORDINANCE BY THE CITY OF IOLA ADOPTING A CHANGE OF ZONING.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF IOLA, KANSAS:

Section 1: The City Council has hereby adopted a change of zoning from I (Industrial) to C2 (General Business) for the following described property:

BOUGHTON'S SUBDIVISION OF IOLA, S26, T24, R18, S 93' LT X & W 346.23' LT T & N2 ABAN RR R/W S THRF SECTION 26 TOWNSHIP 24 RANGE 18, A.K.A. 331 N. COTTONWOOD

Section 2: The City Council has hereby adopted a change of zoning from R-3 (Multi-family) to C-2 (General Business) for the following described property:

BOUGHTON'S SUBDIVISION OF IOLA, S26, T24, R18, PT LT Q, BEG 63' S NW COR, E TO E LT LN, S 87', W TO W LT LN, N TO POB, A.K.A 315 N. COTTONWOOD;


