NEW BUSINESS

A. Fire Truck & Equipment - Bid Awards -

Chief Waggoner gave an overview of the bid process, Noting that a fire apparatus advisory committee of three fire department employees and the Fire Chief was formed to review the bids and decipher the specifications included in each submitted bid packet. Administrative staff had also studied the proposals.

Chief Waggoner presented the bid for the fire engine and fire equipment within the specifications and the equipment bid that followed the purchasing policy as the lowest bid.

The Darley Vision fire engine and the equipment from W.S. Darley & Co. in the amount of \$653,230.54 and the additional equipment from Conrad Fire for \$36,768.72 fall within the amount of allotted money within the Budget, including the CDBG funds.

Council Member Peters asked why there was such a difference between the Pierce model and the Darley model.

Fire Chief Waggoner stated that it's a matter of name and notoriety. Both engines meet the needs of the fire department.

Fire Chief Waggoner stated that Pierce has a service center in Olathe, while Darley's service center is in Kansas City, MO; however, Darley's service center does not have body repairs.

Council Member Ballard asked why Sutphen Fire Engines had not bid.

Chief Waggoner noted that he had contacted Sutphen and sent a bid packet to them. However, they had not sent a bid.

Council Member French noted that stations around Wichita had been having the same problems the Iola has had with the Pierce truck.

Council Member Ballard stated that he had spoken to departments in Wichita. They had problems with the same model that Iola has. They have since been buying several new models from Pierce. Council Member Ballard stated that when he lived in Michigan, the department he worked for switched from Darley Engines to Sutphen Engines.

The council asked to have the members of the Fire Apparatus Committee comment on the two engines.

Corey Isbell informed the Council that the committee had done a lot of research for different trucks. He noted that Pierce came to the station and met with them, discussing the details they wanted on the engine. Darley did not come to the station bidding just to the specifications within the bid packet.

Mayor Wells noted that the Council favors having the department obtain more information on the two different engines.

Council Member French noted that he wanted to ensure that having the engine being pared down to make it "cheaper" doesn't make it a risky situation getting into a vehicle that was not the quality that was needed.

Motion made by Council Member Ford and seconded by Council Member Myrick to table this agenda item to a future meeting for more information to be obtained. All in favor. Motion carried.

B. Allen County Fair Temporary CMB License - Resolution 2021-10-

Motion made by Council Member Myrick and seconded by Council Member Peters to approve Resolution 2021-10 allowing Allen County Fair Association to sell CMB for the special event on July 23, 2021, through July 25, 2021, within the designated area at Riverside Park. All in favor. Motion carried.

City Clerk Hutton reported that Farm City Days had missed the deadline to apply for convention and Tourism Funds, and they are requesting to be considered for funds at this time.

The Council Members stated that they would consider funding for Farm City Days after an application is submitted.

Motion made by Council Member Ford and seconded by Council Member Myrick to approve the distribution of funds as recommended by the Convention and Tourism Committee. All in favor. Motion carried.

She noted that the utilities have not been on for several years, and if individuals live there, that is a code issue.
