GENERAL ORDINANCE 3513

AN ORDINANCE AMENDING CHAPTER 9, ARTICLE I, CONCERNING THE MUNICIPAL COURT AND THE IOLA CITY CODE OF THE CITY OF IOLA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF IOLA, KANSAS:

SECTION 1 AMENDMENT. The City does hereby revise Chapter 9, Article I of the Code of the City of Iola, to read as follows:

Court costs of \$75.00 shall be added to all misdemeanor code violations, infractions and traffic violation fines.

Exceptions to the Standard Fine Schedule:

- (1) For a second offense conviction within a twelve (12) month period, the fine shall be doubled.
- (2) For a third offense conviction within a twelve (12) month period, the fine shall be tripled.
- (3) For a fourth and subsequent offense conviction within a twelve (12) month period, the fine shall be \$500.00. In no event shall a traffic infraction conviction exceed \$500.00


SECTION 2. **REPEAL.** All ordinances and parts of ordinances in conflict herewith are hereby repealed accordingly.

SECTION 3. **EFFECTIVE DATE.** This ordinance shall take effect and be in force after its passage and publication as provided by law.
