Section 1: The City Council has hereby adopted a change of zoning from R-2 (Two-Family Residential) to I (Industrial) for the following described property:

DAVIS 2ND ADD TO IOLA; 702 SCOTT, S34, T24, R18, LOTS 1 TO 6, BLK 6 & VAC  
PARK ST BEG SW COR SAID LT 6, W 50', N 137.2', E 50', S 137.2' TO POB

Section 2: All ordinances or parts of ordinances in conflict herewith are repealed.

Section 3: This ordinance shall take effect and be in force from and after its publication in the Iola Register as provided by law.



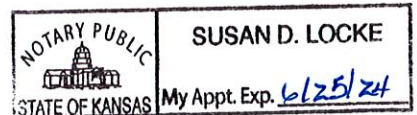
